# Practice;

#### Mediation and Arbitration

Mr. Matheson has been practicing as a third party neutral Mediator and Arbitrator in the Labour and Employment sector for the past ten years. Mr. Matheson practiced as an advocate for Unions for twenty years, during that time he sat as a nominee on several arbitration boards. Mr. Matheson now continues to help workplace parties resolve their disputes or workplace grievances. Mr. Matheson has been included on both Mediator and Arbitrator rosters via workplace collective agreements and their internal dispute mechanisms. Mr. Matheson's appointments by disputing parties also include private collective agreement conciliations and mediations including collective agreement ratification vote supervisions.

Mr. Matheson specializes in Termination grievances, last chance agreements and alleged violations of other labour relations statues including the Occupational Health and Safety Act. Mr. Matheson has been appointed in December 2011and security approved in January 2012 to be part of the DIANA mediation roster, where he is awaiting his first land dispute case between the Federal Government and Ontario or Nunavut based aboriginal communities.

### Workplace Investigations

Mr. Matheson also has been employed as a third party neutral workplace investigator in relation to Bill 168 (alleged) violations. Generally speaking these investigations are fact finding investigations and are done in an informal and non judgemental fashion. These confidential sessions are generally conducted with the help and support of both management and on site union officials, in unionized workplaces. Mr. Matheson commits to all his clients and stakeholders to conduct the investigation in a fair, expedited and transparent fashion.

#### Workplace Consulting

Mr. Matheson has and continues to consult in matters of collective agreement disputes. Mr. Matheson offers to clients, once he has been ruled out as a neutral third party, pre arbitration preparations and role playing for arbitration.

Mr. Matheson has been contracted to consult and give his expert opinions on the likely outcomes of certain grievances. Again this is only when Mr. Matheson is not in contention as a neutral third party.

# Family Mediation and Arbitration

Mr. Matheson is practicing Family mediation and arbitration for the last five years. Mr. Matheson's family mediation practice is centered on working with the Axis Family Mediation team as a MIP presenter and on and off site Mediator at the following sites;
